COVID-19 (Prevention and Control) (Physical Distancing) (Amendment) Order

STATUTORY INSTRUMENT, 2020, No. 163A

[23rd October, 2020]

In exercise of the power conferred under section 17 of the COVID-19 (Prevention and Control) Act, No. 9 of 2020, the Minister responsible for health, makes this Order:

Citation

1. This Order may be cited as the COVID-19 (Prevention and Control) (Physical Distancing) (Amendment) Order, 2020.

Replacement of section 4

2. The COVID-19 (Prevention and Control) (Physical Distancing) Order, Statutory Instrument, No. 151 of 2020 is amended by deleting section 4 and replacing the following —

"Educational institutions

- **4.**—(1) An educational institution shall remain closed until the 9th day of November, 2020.
- (2) Subsection (1) does not prohibit an activity that can be performed by electronic or virtual means.".

STATUTORY INSTRUMENT, 2020, No. 163B

[23rd October, 2020]

In exercise of the power conferred under section 16 of the COVID-19 (Prevention and Control) Act, No. 9 of 2020, the Minister responsible for health, makes this Order:

Citation

1. This Order may be cited as the COVID-19 (Prevention and Control) (Prohibition of Assembly) (Amendment) Order, 2020.

Amendment of section 2

- **2.** The COVID-19 (Prevention and Control) (Prohibition of Assembly) Order, Statutory Instrument, No. 153 of 2020 is amended
 - (a) under subsection (1), by deleting the words "that consists of more than five hundred persons" and replacing the words "that consists of more than fifty persons";
 - (b) by inserting immediately after subsection (1) the following new subsection (1A)
 - "(1A) Notwithstanding subsection (1), a faith-based organization may hold a religious ceremony with an attendance of not more than one hundred persons.".
